### U.S. PRESIDENT

Represents the nation's values. Is responsible for enforcing laws passed by Congress, directing U.S. foreign policy, shaping the economy, and has authority over the military.

**Kamala Harris (D)**  
Age: 59

- **Action Taken:**
  - As Vice President, supported the *Freedom to Vote: John R. Lewis Act*, a comprehensive voting rights bill.
- **Commitments:**
  - Supports legislation to block rent price fixing by corporate landlords and stop large investment banks from buying homes in bulk and marking up prices.
  - Supports raising the federal minimum wage from \$7.25 per hour.
  - Supports legislation restoring reproductive rights at the federal level.
- **Work/ Electoral Background:**
  - Current Vice President - first woman as well as first Asian American and first African American to assume the role.
  - Former U.S. Senator for California from 2017 to 2021.
  - Former DA/City Attorney in San Francisco, CA.
  - Graduate of Howard University.

**Donald Trump (R)**  
Age: 78

- **Actions Taken:**
  - Rejected and attempted to overturn the 2020 election.
  - Appointed three U.S. Supreme Court Justices in order to overturn *Roe v. Wade*, removing a decades-long federal protection for abortion.
- **Commitments:**
  - Seeks to carry out the largest deportation of migrants in U.S. history.
  - Plans to remove Title XI expansions that protected victims of sexual abuse and expanded protections for LGBTQ+ and pregnant students on college campuses.
- **Work/Electoral Background:**
  - Only former president with no previous legal/government work.
  - Convicted felon.
  - Former NY Realtor and Reality TV Host.

### U.S. SENATE

Decides what laws get passed in the country such as climate policy, gun laws, and reproductive care. A Senator can block critical legislation and stall change we care about.

**Tammy Baldwin (D- Incumbent), Age: 62**

- **Action Taken:**
  - Introduced the *Freedom to Vote Act* and supports the *Preventing Election Subversion Act*. The *Freedom to Vote Act* is a comprehensive voting rights bill.
- **Commitment:**
  - Vocal about ending partisan gerrymandering and protecting access to drop boxes.
- **Work/Electoral Background:**
  - Senator since 2013.
  - Served in Dane County Board of Supervisors.

**Eric Hovde (R)**  
Age: 60

- **Action Taken:**
  - Established a foundation focused on advancing research for multiple sclerosis cures and creating transitional homes for survivors of child trafficking.
- **Commitment:**
  - Opposes the Green New Deal, arguing that it would devastate Wisconsin's farmers and agricultural sector while significantly increasing already high utility rates. The Green New Deal is a policy proposal aimed at addressing climate change and economic inequality.

- **Actions Taken:**
  - Co-sponsored the *John R. Lewis Voting Rights Advancement Act* and the *For The People Act*, comprehensive voting rights bills.
